LRCA General Body Meeting (via Zoom) Minutes* June 1, 2020

President Foxworth opened the meeting at 7:03 pm and welcomed residents, Rev. Paul Smith led an opening prayer.

Tanya Slade, LRCA Treasurer: Presented the Treasurer's Report including LRCA having a balance of \$8,465.11 (written copies available). A motion was made, seconded to accept the Treasurer's Report and it was approved.

President Foxworth presented the March Minutes (from our last in-person meeting given Covid19) and a motion was made, seconded to accept the minutes as presented in the newsletter.

Ward 4 Councilmember Todd's Office: Gary Johnson provided an update on planned street improvements, also noted that rental cars left in our Community should be ticketed, etc.

Ward 5 Councilmember McDuffie's Office: Barbara Mitchell provided an update on public safety concerns, etc., noted that she's leaving the Councilmember's Office for another job and that this will be her last meeting. President Foxworth thanked her for all that she's done for the Lamond-Riggs Community, noted that we enjoyed working with her and that she'll be missed!

Guest Speaker: Ronald King, DC Dept. of Health: Provided an update on DC's Covid19 response. His remarks included reminders to wash your hands frequently throughout the day, wear a mask, keep at least 6 ft. away from others when you're out and limit going out of the house. Ronald also noted that there's a chemical in soap that actually the virus, that's why washing your hands frequently is so important!

Committee Updates: <u>Our Education Committee</u>, Chair Marsha Pender noted that they have begun reviewing applications the LRCA scholarship and will award a total of \$3,000 to college bound graduating seniors who live in Lamond-Riggs. <u>Our Senior Committee</u>, Vice Chair Rodney Foxworth reminded all that the planned workshop for June has been cancelled due to Covid19. Our <u>Development Task Force</u>, Chair Rodney Foxworth noted that Task Force members participated in meetings with the developers of the proposed Chic Fil A and EYA Townhouses. We have the plans for both project and will review, provide feedback to the developers re: any Community issues. LRCA and ANC Commission Gordon Fletcher will work together to provide oversight of the Cafritz project and have appointed Deborah Grimsted as the Community Liaison to that project. <u>Our</u> Newsletter Committee, Chair Rev. Mays noted we'll resume producing, distributing the newsletter electronically in the Fall.

Community Concerns, Announcements: There were none. President Foxworth thanked everyone for participating in the first LRCA meeting via Zoom and wished all a good and safe summer!

The meeting ended with a closing prayer by Rev. Paul Smith and adjourned at 8:45pm. LAST YEAR'S SUCCESSESS!!

Here's a summary of what LRCA did last year: 1- Provided timely, important Covid19 info to residents via emails, our listserv, website, Facebook/twitter accts.. 2- Distributed 170 free face masks (cloth, disposable) to 40 Lamond-Riggs seniors, elders, families in need incl. bottles of hand sanitizers, 3- Strongly advocated for & worked with MPD to implement revised Sector Plan for Policing by the Riggs-LaSalle Rec. Ctr. and Backus Elem. Sch.,4-Had four Committees that worked hard all year: Ed - Marsha Pender Chair, Seniors - Rev. Mays Chair, the Development Task Force - Pres. Foxworth Chair and the Newsletter - Pres. Foxworth Lead, 5- The Sr. Committee developed a "first of its kind" workshop for Srs., to learn about & apply for City, Non-profit Sr. Services online/ manually in the workshop, 6-Assisted in, promoted the need for resources for families who experienced terrible fires in our Community, 7- Researched virtual meeting platforms (Zoom, Meet Up, Teams, Webex, etc.) and agreed to use Zoom, 8- Switched to virtual General Body, Board and Committee mtgs. via Zoom and held a Zoom training for the Board. 9- Provided factual info to the Community re: the proposed playaround and asked that comments be sent to DPR, 10- Passed LRCA's 1st itemized budget in decades, 11- Helped to coordinate and participated in a Happy 100 Years! Car Parade to celebrate a resident's birthday, 12- Recruited a Treasurer, Financial Secretary and Recording Secretary for the Board, 13- Developed Task Force Community Liaison positions as "point persons" for the Cafritz, EYA developments, 14- Significantly reduced newsletter costs, 15- Sent reps. to DC's Federation of Civic Assn. Annual Mtg., 16- Joined the Center for Nonprofit Advancement to help with our non-profit responsibilities; 17- Filed reports with DCRA & IRS, 18- Made 1st ever robocalls to residents re: the June mtg. and finally **19**- The Board held votes since April & agreed to: Award \$3,000 in scholarships; Raise at least \$3,000 annually for our scholarship fund and not use reserve funds without General Body approval; Send sympathy cards to 14 families of residents who recently passed; Support merger talks between DC Civic & Citizen Assns.; Send a support letter for our Main St. Program's proposal; Provide \$50 for cloth, disposable masks to distribute to needy seniors, elders and families; Opposed a day care's zoning exception, sent testimony to the BZA; Provide \$15/mth. for a Zoom acct.; Provide \$240 for a media consultant to provide TA for our Zoom acct., Board training and coord. Zoom General Body meetings (many associations across the City did not continue their meetings at all).
