DC Summer Camps Registration 2022

Does your alley need a bit of sprucing up? Call 311!

The DC Department of Public Works (DPW) will clean residential alleys once every six weeks between the months of March and October. In between cleanings, residents are asked to pick up litter in the alleys. You can request alley cleaning by calling 311.

Fort Totten Trash Transfer Station Closure

April 2, 2022, will be the last day the Fort Totten transfer station will be open for bulk and residential drop-off until the Fall of 2022. This is in the effort to improve the quality of the runoff stormwater generated by the bulk trash collected from residents. Operations will be moved to the Benning Road Transfer station located at 3200 Benning Road, NE. Beginning April 6, 2022, bulk and residential drop-off will take place Wednesday through Friday from 10 am until 2 pm. Residential drop-off is an alternative to scheduled bulk pick-up. DPW recommends that residents use 311 to schedule a bulk pick-up at a time convenient for the resident. Residents can schedule up to seven items per service request. Pick-ups are collected within 14 days of a scheduled service request. Household Hazardous Waste drop-off will continue Saturdays from 7 am until 2 pm. Shredding will take place on the first Saturday of every month from 7 am until 2 pm.

Last day of school for DCPS is Friday, June 24, 2022.

MARCH 2022 MEETING MINUTES—March 7, 2022

Meeting opened at 7:00 pm. President Rogers went over housekeeping rules and then deferred to Rev. Paul for the opening prayer.

**Change in agenda:* A motion made to revise the agenda to allow DC Parks/Rec to present in lieu of LaSalle School. motion was passed.

Secretary's Report: Body omitted to approve December 2021 minutes at the February meeting. President made a motion to accept December/February minutes as printed in respective newsletters. Motion made and duly seconded to approve both minutes; body approved December 2021 and February 2022 minutes. There was no January 2022 meeting.

Treasurer's report, presented by treasurer Audrey Walker: Beginning balance: \$9,500.20. Total deposits: \$215.00. Total expenses: \$274.34. Ending balance: \$9,440.60. Hearing no objections to the report, it was moved, and duly seconded, to vote on the report as it stands. The body passed the motion that the Treasurer's Report be accepted into the record.

Elected Officials and PSA—Councilmember Janeese Lewis-George—Legislative Updates: Legislative meeting last Tues; Councilmembers are back at Wilson building for in-person legislative hearings. Masks and proof of vaccine are still required for entry. Last hearing: expanded paid family leave benefits for the private sector. Extended from 8 to 12 weeks. July 1, 2022 will go into effect.

*Passed emergency legislation for DCPS teachers and staff to run for DC Board of Education in time for the general election of this year.

*Legislation passed on eviction ceiling for those unhoused with vouchers.

*Oversight hearings completed. Confirmation from DGS on getting HVAC systems at Lamond, Riggs-LaSalle, and other Rec centers.

*Will do a screen walk through with DGS and DPR at public schools. Go through work orders.

*Budget to move up modernizations for LaSalle, Truesdale and Whitter
